

# 2024 Chi Epsilon Sigma Chapter Awards



#### How to nominate a Chi Epsilon Sigma Member:

- Fill out the form and choose an award category on the following page. (Award categories with descriptions are attached)
- Complete the nomination form. Submit it along with supporting documents (if required) and a photo of the nominee to <a href="mailto:showard@uky.edu">showard@uky.edu</a>.
- Nominations are due by March 5, 2024.

#### Who may be nominated?

- Any current Chi Epsilon Sigma member is eligible. There may be other eligibility requirements depending on the award category which is listed in the award descriptions.
- Only one person may be nominated per nomination form (no team nominations).
- Previous winners may be nominated; however, no award can be won in consecutive years.

#### Who may nominate a Chi Epsilon Sigma member?

- Any staff member, agent, or employee of the University of Kentucky Cooperative Extension Service.
- Self-nominations are encouraged.
- Multiple people may work together to nominate the same CHIES member.
- The same nominator may nominate more than one staff member, but not on the same form.

#### How are winners selected?

- Executive Board Members from The Extension & Research Support Staff Association and our Chi
   Epsilon Sigma Sister Chapters (Ohio State, Arkansas, and Louisiana) will be asked to judge the awards.
  - If the Awards Committee is unable to secure judges from those organizations, UK Extension Agents will be asked. Agents will not judge nominees from their county.
- The judges will select a first, second, and third-place winner in each category. The first-place winner in the Distinguished Service, New Achievers, Digital Communications, Print Media, Outstanding Program, Good Friend, and Jovial categories will receive \$50. All winners will be recognized and presented with a certificate and/or award.
- The winners will be recognized at the Annual Chi Epsilon Sigma meeting in April.
