CHIES Q&A ZOOM

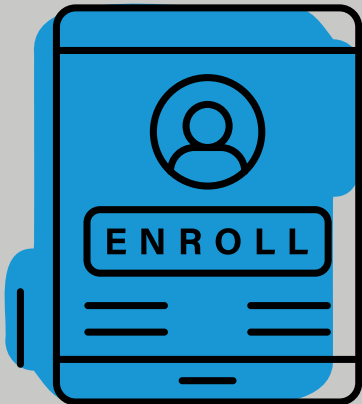
