### New Administrative Structure for CH1ES Directors

At our annual meeting, we voted to update our bylaws to mirror the new administrative structure of Extension. Instead of having one director from each Extension Area, we will now have six directors from each Extension Region. As before, we will continue to have two non-county directors: UK Campus Lexington and UK Campus Princeton. This will be a total of 20 directors. Directors will continue to serve a two-year term. Previously, seven areas were elected in even years and the other seven were elected in odd years. We will now elect three directors for each region in even years and the other three in odd years. UK Campus directors will be elected as before: Lexington in even years and Princeton in odd years.

Migrating the old areas into the new regions will be a three-year process. Directors who were elected in 2020 will continue to serve their second year. The areas that were up for election this year were filled. The 16 directors currently serving will be counted toward their appropriate region. We will fill the remaining positions over the next two years.
